

# Rose Valley Campground Regulations

1. The Rose Valley Campground is limited to use by recreational vehicles only. A “recreational vehicle” means a travel trailer, motor home or similar vehicle, equipped with a washroom and water and sewage holding tanks, designed to provide temporary accommodation for travel, recreation, leisure or vacation purposes, but does not include a mobile home that is constructed and used for year-round occupancy.
2. An individual campsite is limited to use by one recreational vehicle. Tent sites are not available.
3. The campground has 4 designated campsites each serviced by power.
  - a. Power to a campsite will only be turned on when fees are paid and during Office hours. Contact the Administrator at 306-322-2232 during Office hours to have power turned on. Office hours are 10 am to noon and 1 pm to 4 pm Monday to Friday.
  - b. Campsite 1 and 2 (the 2 north campsites closest to McCallum Street) have 30 amp power available.
  - c. Campsite 3 and 4 only have 15 amp power. If a camper blows the breaker the power will only be restored during Office hours (a 15 amp service will only carry basic uses – air conditioners will generally draw too much power).
4. Campground site rental is a first-come, first-serve basis. Campsites shall not be reserved.
5. Use of the facilities is on an “as is” basis. The Town is not responsible for damage to any property left on the campsite.
6. The following fees shall apply per campsite and such campsite fees shall not be prorated.

Length of Time using the campsite	Rental fee	Fees are Due
Per Day	\$10 (ten dollars)	Prepaid on Day 1 of rental
Per Week	\$50 (fifty dollars)	Prepaid on Day 1 of rental
Per Month	\$200 (two hundred dollars)	Prepaid on Day 1 of rental

7. Fees shall be paid at the Town Office during regular Office hours.

The Rose Valley Town Office is located at 217 Centre Street. The contact number for the Town Office is 306-322-2232. Regular Office Hours are 10 am to noon 1 pm to 4 pm Monday to Friday. Fees may be paid by cash or etransfer may be available when the Office is open. Extended stay clients may pay by cheque. Alternate contact will be provided on the Town voice mail server for Administrative extended absence (vacation, medical leave etc.), so please phone 306-322-2232 and follow the instructions if you receive an extended absence message. Note during Administrative leaves only cash or cheque will be accepted by the Town Foreman.
8. All grey/black water must be contained. If disposing at the campground such water must be disposed of at the trailer sewage disposal. Disposal of grey / black water on the ground is prohibited.
9. Campsites must be kept clean and tidy with no garbage or debris loose on the grounds. Garbage shall be placed in the provided containers. Please put your garbage in garbage bags prior to putting in the garbage container. Do not put garbage in the Recycle containers.

10. Open fires are not allowed.
11. Pets must be kept leashed and controlled at all times. Pet feces must be cleaned up and bagged immediately. Please, do NOT dispose of un-bagged pet feces in the garbage containers.
12. Setting off fireworks is prohibited within the campground or on the adjacent lands.
13. All bylaws enacted within the Town of Rose Valley apply to the campground.
14. Campsites are maintained (mowed) as necessary as determined by Public Works. Generally mowing will occur WEEKLY on THURSDAY weather permitting.
  - a. Clients are required to ensure all personal property is properly store or removed to allow unrestricted operation of a riding lawn mower during maintenance.
  - b. The Town is not responsible for damage to any property left on the campsite during maintenance.
15. Contravention of any section of this bylaw may result in eviction. Eviction notice may be served by personal delivery or posting on the recreational vehicle or shelter. In case of eviction all fees paid are forfeit.
16. A recreational vehicle sewage dump station is available onsite.
